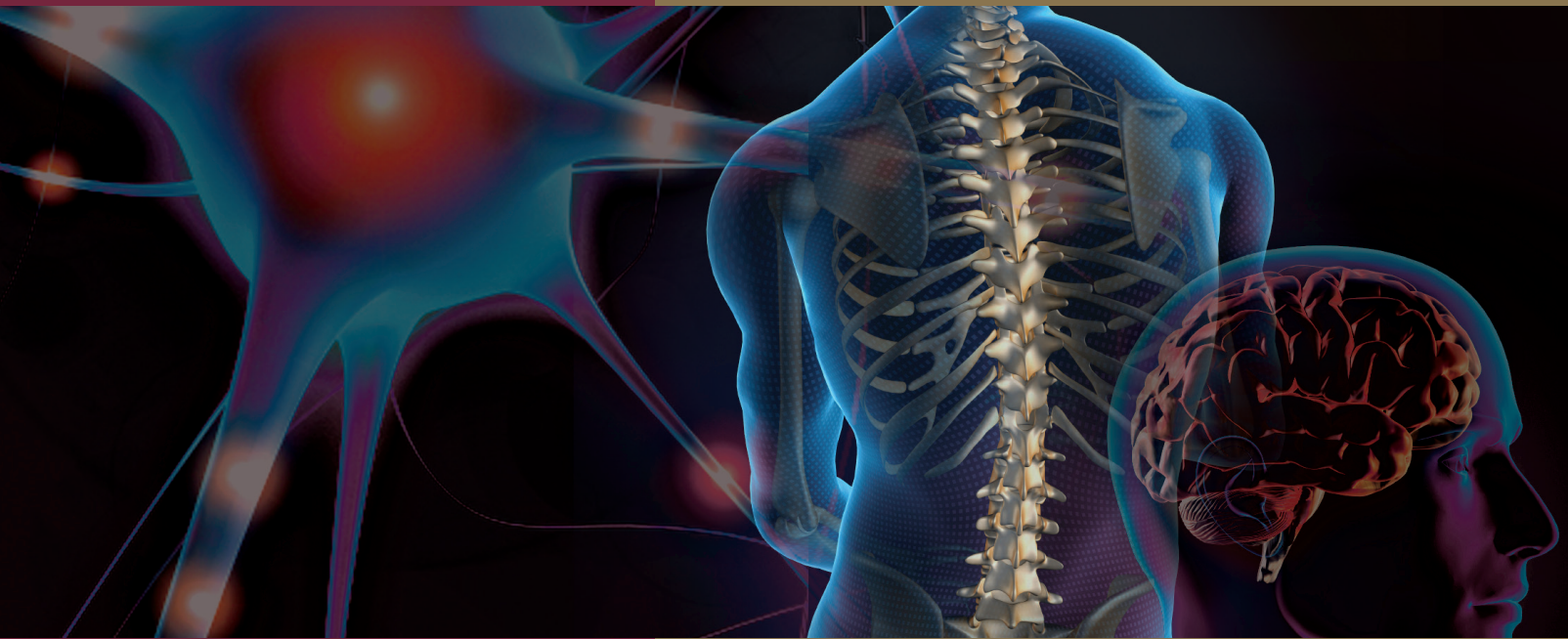

## GOODMAN ORAL BOARD PREPARATION: Neurosurgery Review by Case Management

This year, the must-attend American Association of Neurological Surgeons (AANS) *Goodman Oral Board Preparation* course has been updated to reflect the changes in the American Board of Neurological Surgery (ABNS) Oral Board Exam. Practicing neurosurgeons who register for the full course will have the opportunity to attend at least four breakout sessions specific to their subspecialty to assist in preparation for the focused practice portion of the exam. Register now for this one-of-a-kind course to enhance your case-management skills, identify knowledge gaps and pass the ABNS Oral Board Exam.

### LEARNING OBJECTIVES

Upon completion of this course, participants should be able to:

- ▶ Discuss contemporary neurosurgery topics, including general, trauma, spine, vascular, tumor, pediatrics and peripheral nerve.
- ▶ Comprehend the format of the ABNS Oral Board Exam.
- ▶ Compare their approach to standard and complex neurosurgical problems with those of their contemporaries.
- ▶ Identify those areas of neurosurgery where further study would be beneficial in preparation for the ABNS Oral Board Exam.

Dr. Levi graduated from the University of Ottawa Medical School. He completed his residency at the University of Toronto,

as well as a spine fellowship at the Barrow Neurological Institute (BNI) in Phoenix. He completed a PhD in neuroscience in human Schwann cell biology at the University of Miami during his residency. He is a professor and chair of neurosurgery at the University of Miami Miller School of Medicine and is the chief of the neurosurgery service at Jackson Memorial Hospital. He recently received the Robert M. Buck Distinguished Chair in Neurological Surgery. Dr. Levi is the director of the AANS *Goodman Oral Board Preparation: Neurosurgery Review by Case Management* course and is currently a member of the AANS Education and Practice Management Committee.

### THIS COURSE CONTAINS TWO CONCURRENT SESSIONS:

**Plenary “Hot Seat” Sessions:** The plenary sessions provide a simulated board exam experience by covering more than 200 case scenarios. “Hot seat” participants formulate responses to mock exam questions while other attendees observe how best to formulate, organize and present responses to case scenarios. New this year, sessions will address and analyze your cases in preparation for the case-based portion of your exam, including clinical history, physical examination, key imaging, diagnosis and management, surgical coding, early result and follow-up.

**One-on-one Sessions:** The one-on-one breakout sessions consist of one participant and one faculty. Experienced neurosurgeons will critique your patient management response and your ability to organize responses to simulated oral board questions. The breakout sessions are intense and comprehensive.

\*The AANS *Goodman Oral Board Preparation* course full-course registration consists of the Plenary Sessions and approximately four one-on-one breakout sessions in your subspecialty. The one-on-one breakout sessions occur simultaneously with the plenary session, are spread out over the three-day course and consist of one participant and one faculty member going over cases. Each breakout and each "hot seat" session lasts 30 minutes. Space in the full course is limited, but once it is sold out, attendees can still register for the Plenary Session only.

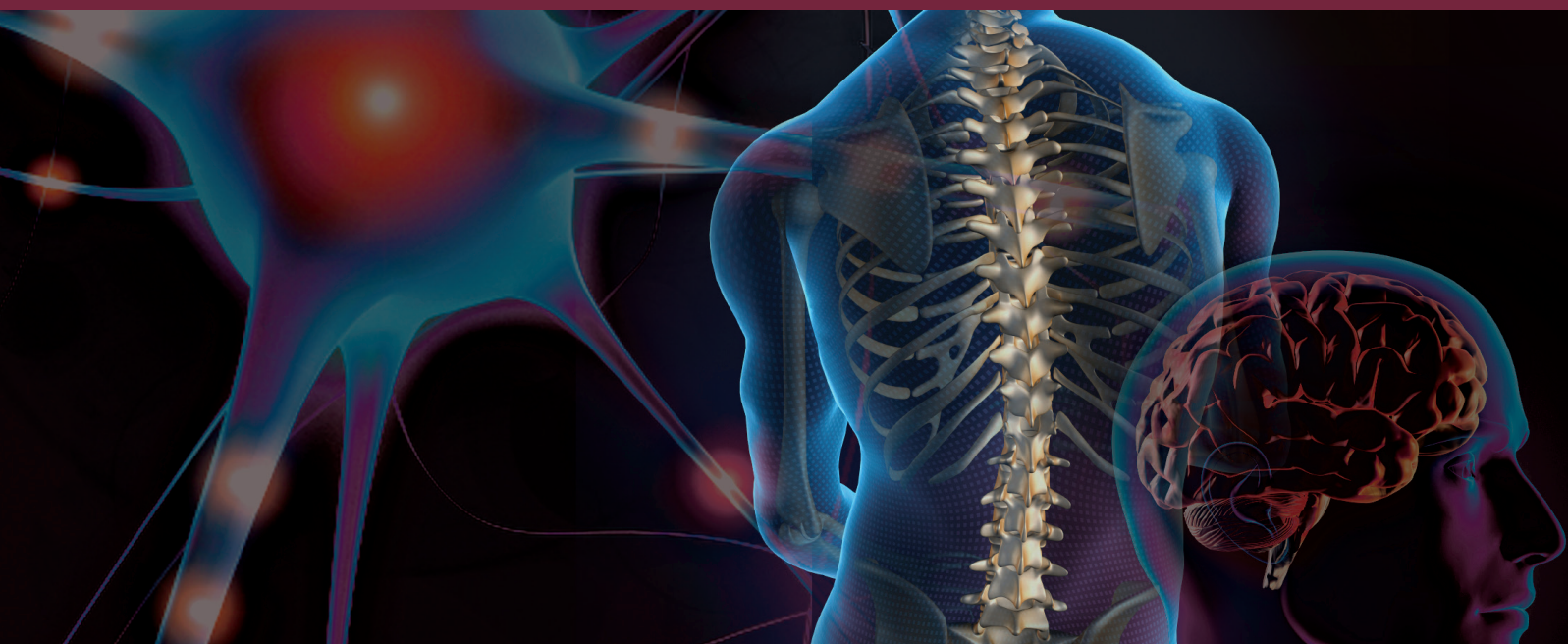
