**Re: Prior Authorization in Medicare Advantage Plans**

Dear Chairs DeGette and Pallone and Ranking Members Griffith and McMorris Rodgers:

The Alliance of Specialty Medicine writes to thank you for examining Medicare Advantage (MA) plans during the upcoming hearing “**Protecting America’s Seniors: Oversight of Private Sector Medicare Advantage Plans.**” The Alliance’s mission is to advocate for sound federal health care policy that fosters patient access to the highest quality specialty care. As patient and physician advocates, the Alliance supports **H.R. 3173, the *Improving Seniors’ Timely Access to Care Act***, which would improve the prior authorization process in MA plans through increased transparency and the establishment of an electronic prior authorization process and urges the committee to advance this legislation.

Prior authorization is a cumbersome process that requires physicians to obtain pre-approval for medical treatments or tests before rendering care to their patients. The process for obtaining this approval is lengthy and typically requires physicians or their staff to spend the equivalent of

two or more days each week negotiating with insurance companies — time that would better be spent taking care of patients. H.R. 3173 will help streamline, standardize, and modernize prior authorization in the MA program.

We urge the committee to act on this important legislation which would reduce the administrative burdens of prior authorization in the MA program. We look forward to working with you to advance H.R. 3173, the *Improving Seniors' Timely Access to Care Act*.
