Dear Representatives Correa and Burgess:

The undersigned members of the Health Coalition on Liability and Access enthusiastically support the *Coronavirus Provider Protection Act* (H.R. 3021) and applaud you for your commitment to protecting healthcare professionals, and the facilities in which they practice, from the serious threat of COVID-19-related liability lawsuits.

The limited and targeted protection from liability provided by H.R. 3021 will help ensure that healthcare professionals and facilities who have served on the front lines of the coronavirus pandemic are not drawn into unwarranted lawsuits resulting from the selfless care they have provided. This legislation is a comprehensive, federal solution to a national crisis that cannot be solved by state legislation alone, as demonstrated by the varied efforts undertaken by state legislatures. The patchwork nature of state protections, in addition to efforts to repeal them where previously enacted, reveal that federal action is still needed.

Passage of this bipartisan bill will reduce lawsuits that could result from the health care workforce shortages, inadequate safety supplies, and changing guidance from federal, state, and local government officials that were typical in the early stages of the pandemic. At the same time, it would maintain necessary mechanisms to help patients harmed by substandard care. Your legislation will truly benefit both patients and clinicians alike.

Until the *Coronavirus Provider Protection Act* is passed, the very healthcare providers and facilities that have been celebrated as our nation's heroes remain vulnerable to the threat of unwarranted liability lawsuits. We are committed to working with you to ensure that this threat is avoided so the highest level of care may continue to be provided to those both directly and indirectly affected by the pandemic.
